This Administration directive requires Federal agencies to purchase various "green" items (including BioPreferred products) in 95 percent of all applicable contracts.

BioPreferred includes a preferred procurement program for Federal agencies and contractors, and a voluntary labeling program for the broad scale consumer marketing of biobased products.
